Sanitary regime rules introduced to prevent the spread of SARS-CoV-2 virus during the ANIMARKT Stop Motion Forum

Safety rules for event participants

1. The organizer of the events and meetings (hereinafter referred to as the "Event") taking place as part of the ANIMARKT Stop Motion Forum 2021 event is MOMAKIN Sp. z o.o. based in Łódź (90-135) at ul. Narutowicza 34/303.
2. Persons participating in the events are required to read these regulations (hereinafter referred to as the "Regulations"), posted on the website www.animarkt.pl
3. Participation in the Events is tantamount to accepting the Regulations.
4. The number of places at selected events is limited and the order of applications decides.
5. Participation in the events organized as part of the ANIMARKT Stop Motion Forum in Łódź is free of charge. Prior registration is required at www.animarkt.pl.
6. Throughout the event, it is obligatory to cover the nose and mouth with a mask (do not use visors or clothing). The participant is obliged to obtain a mask on his own.
7. Persons ignoring the above order will not be able to participate in the event.
8. Persons present on the premises of the event are required to disinfect their hands.
9. Only people with a certificate confirming that they have received the full dose of the COVID-19 vaccine will be allowed to enter the event area. The presentation of the certificate will be necessary to collect the wristbands entitling you to participate in the event.
10. The presentation of a vaccination or recovery certificate is voluntary. Failure to present it may result in the inability to provide the service in a stationary form, i.e. ensuring participation in the event in the EC1 building complex.
11. Only people with a certificate confirming that they have received the full dose of the COVID-19 vaccine will be allowed to enter the event area. The presentation of the certificate will be necessary to collect the wristbands entitling you to participate in the event. Vaccines authorized in the European Union are honored:
 - mRNA vaccine called Comirnaty (BNT162b2) from Pfizer and BioNTech

- an mRNA vaccine called Spikevax (mRNA 1273) from Moderna
 - AstraZeneca vector vaccine called Vaxzevria
 - COVID-19 Vaccine Janssen (Johnson & Johnson) vector vaccine
 - and vaccines included in the list of vaccine equivalents authorized for marketing in the territory of the Republic of Poland, kept by the National Institute of Public Health of the National Institute of Hygiene - National Research Institute (the list is available here: http://bip.pzh.gov.pl/public/get_file.php?id=540289)
1. The event participant is obliged to provide the organizers with his contact details (name, surname, e-mail and / or telephone number). If any of the participants is infected with SARS-CoV2, the data will be used to inform about a possible contact with an infected person. The organizers are also required to provide a list of participants and employees of the County Sanitary and Epidemiological Station.
 2. In the event area, the organizer recommends keeping a distance of 1.5 meters.
 3. If a participant develops symptoms or symptoms that may indicate SARS-CoV-2 infection, such as: fever, cough, shortness of breath, trouble breathing, muscle pain, general fatigue, low-grade fever (body temperature between 37.2 ° C and 38 ° C), cold symptoms, loss of smell and taste, the participant is obliged to immediately inform the event staff about it.
 4. There are restrictions on the number of people present at the event site. As at the date of drawing up the regulations, the limit is one person per 15 m². The limit may change according to the current recommendations regarding sanitary restrictions.
 5. The participants will leave the event area by exits designated by the staff and organizers.
 6. The event participant is obliged to comply with the current sanitary restrictions and recommendations.
 7. The event participant is obliged to comply with the Regulations of the event.
 8. A participant who breached the Regulations is obliged to leave the Festival area immediately upon request of the staff.
 9. Participants of the events agree to the processing of personal data contained in the Application Form for the purposes of organizing the Event (in accordance with the Act of August 29, 1997 on the protection of personal data, consolidated text, Journal of Laws of 2002, No. 101, item 96).
 10. The organizer owns the right to amend the Regulations.
 11. Organizers will answer questions about the Regulations and participation in events at: animarkt@momakin.pl.

Additional security measures provided by the organizer

1. Information on the safety rules and the recommendations of sanitary services will be placed on the premises of the event.
2. The organizer will provide disinfectant dispensers in the event area, in a way that will enable participants to disinfect their hands.
3. The organizer enables virtual participation in the event via the internet platform for people who, for various reasons, cannot participate in the stationary formula (e.g. due to SARS-CoV-2 virus infection or quarantine).
